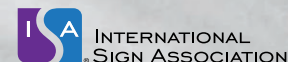

## Membership Information & Application

**TSSA membership dues are determined according to your membership division.**

### • Sign Company:

Any firm, subsidiary, division, or department engaged in the design, manufacture, sale, lease, installation, and/or servicing of signs. Dues are determined by number of employees.

### • Supplier:

Any firm, organization, or person that provides supplies to sign companies of products, equipment, and services used in the manufacture, installation, and servicing of electric and commercial signs. Suppliers include product/component manufacturers, distributors, and independent manufacturer sales representatives.

### • Associate:

Any firm, organization, or person that provides professional or technical services to sign companies. For example: CPA's, consultants, employment services, insurance agents, etc.

## Classifications and Annual Dues Structure

Sign Company (1 - 9 employees)	\$150*
Sign Company (10 - 24 employees)	\$250*
Sign Company (25 or more employees)	\$350*
Manufacturer's Representative	\$200
Sign Supply Distributor	\$500
Product Manufacturer	\$300
Associate	\$200
